Please be advised that the rules and policies of the District apply to the campgrounds. By initialing and signing this form, you agree to observe and abide by all rules and policies of the District. Please initial:

- \_\_\_\_\_ I have reviewed a copy of the campground rules and Policies of the District, and I will abide by them.
- \_\_\_\_\_ Camper releases the district from any liability related to the use of the campground by the camper or anyone claiming by and through camper, including without limitation family members, invitees, guests, and others invited by the camper to the campground. Camper uses the campground at their own risk and shall agree to indemnify the district against any and all losses, damages, claims, suits, actions at law, judgments and costs, including attorney's fees, which may arise or grow out of any injury or death to a person or damages to property caused by the camper's stay at the campground.
- \_\_\_\_\_ Upon the cancellation or termination of this agreement for any reason, including abandonment or expulsion, camper agrees to remove the RV and all personal property from the camping pad. Any RV or personal property remaining on the camping pad five (5) days after cancellation or termination of this Agreement may be disposed of by the District in a manner the District may choose, including but not limited to, sale or destruction of any such property without liability to the District without the necessity of any further action, pursuant to the Rules and Policies of the campground.
- \_\_\_\_\_ I understand that I may not stay at any one pad for more than twelve (12) consecutive months. The district is not responsible for providing another pad for my use.
- \_\_\_\_\_ Payment due date is every 30 days with 1<sup>st</sup> payment due on the Date of Acceptance. Auto-pay can be set-up and is recommended to help avoid late fees (credit card information will be required). Payment is due by 12noon on due date and considered late at 12:01PM of Due Date.
- \_\_\_\_\_ I understand that my Credit Card on file will be used to pay any unpaid balances.
- \_\_\_\_\_ Guest Credit can only be used in Timberlake, Goshen Springs, Coal Bluff, Leake County, and Low Head Dam Campgrounds.
- \_\_\_\_\_ Booking Fees and Credit Card Fees are non-refundable.
- \_\_\_\_\_ I understand that my recreational vehicle must be licensed, insured, and road worthy.

Except for nightly campers, this Agreement will automatically renew each month (based on date of arrival).
