Professional Water and Wastewater Maintenance and Repair Services Pearl River Valley Water Supply District PRV# 25-100-8-99

A number of questions have been asked by prospective respondents. The questions are listed below along with PRVWSD's responses.

1. **Question:** List of every water/sewer maintenance crew member presently employed, including name, position, salary and length of service.

Response: The requested list is attached. Employee names are not provided, for privacy reasons, however; once a contractor is selected, names will be provided to allow the contractor to identify current PRVWSD employees the contractor may want to try to hire. All PRVWSD employees are free to accept employment with the selected contractor, but will not be required to do so. Any current water/sewer employees who remain employed by PRVWSD will be assigned other duties.

2. **Question:** Can PRV provide a list of work order requests from 2024, including any available description of the repairs required to complete the work orders?

Response: The requested list is attached.

3. **Question:** Can PRV provide a list of emergency calls from 2024, along with any relevant details regarding the nature of the issues and the repairs performed?

Response: The requested list is attached.


4. **Question:** General list of equipment and trucks dedicated to the water & sewer department.

Response: The requested information is included on the list of water/sewer maintenance crew members (See Attached list in response to Question #1).

5. **Question:** Will the Contractor be required to furnish personnel certified as water and/or sewer operators, or will PRV's operator satisfy this requirement.

Response: PRVWSD has a certified water operator on staff to satisfy the water system operator requirements. PRVWSD will contract for the services of a certified wastewater treatment plant operator for the Ratliff Ferry WWTP separately. This is the only WWTP owned by the District. These are the only certified water or wastewater personnel required, so the Contractor will not need to provide any personnel with water or wastewater operator certifications.
